## How to Receive Counseling and File a Complaint

- 1. Anyone can receive counseling and file a complaint.
  - You can choose to either receive counseling or request an investigation into cases of human rights violations and discrimination.
  - Anyone aware of a human rights violation can file a complaint.

#### 2. Confidentiality of investigation.

- We ensure strict confidentiality of all complaints in accordance with the "National Human Rights Commission Act.]
- For detainees in detention facilities, additional safeguards are in place; complaint letters cannot be opened within the facility, and tampering with these letters is a punishable offense under the law.
- If detainees request an interview, an investigator from the NHRCK will visit them to address their concerns.

#### 3. The complainant is protected by the NHRCK.

- Complainants are protected by law to ensure they do not face unfair treatment or disadvantages for submitting statements, testimony, or evidence related to their complaints or during the investigation process.
- Any act of obstructing a detainee's rights to file a complaint through abuse of authority is strictly prohibited by law.
- 4. You can visit regional human rights offices for counseling and making a complaint.
  - You can receive counseling and make a complaint though regional human rights offices located in Busan, Gwangju, Daegu, Daejeon, Gangwon(Wonju) and Jeju

# 5. The NHRCK provides various options to receive counseling or make a complaint.

• Counseling and complaints can be made through your preferred method including in person visit, phone, mail, fax, e-mail, and NHRCK web page.

Principles Relating to the Status of National Institutions

The <sup>r</sup>Paris Principle<sub>J</sub> also known as a <sup>r</sup>Principle Relating to the Status of National Institutions<sub>J</sub> is a framework sets out the composition, status, and function of national human rights institutions. With the adoption of the Paris Principle by the UN General Assembly the national human rights Institutions began to be recongnized globally.

#### Guarantees of Broad Competence

Empowered to promote, protect, and advise on human rights.Collaborate with international organizations.

- Investigate and provide remedies for violations.

#### Ensuring Independence

- Operates independently from government branches (legislative, judiciary, executive).
- Secured funding and infrastructure for operational stability.
- Ensures members' independence and status.

#### Pluralistic Composition

- Composed of representatives from diverse social groups with expertise in human rights.

- Reflects pluralistic and inclusive perspectives.

#### Methods of Operation

Freedom to address issues within its mandate.
Access to necessary information and documents.

- Engage with the public, media, and NGOs for advocacy and recommendations.

Quasi-judicial body



A national institution that actively promotes peoples' rights and conducts activities to protect and promote human rights defined by the NHRCK Act

An independent body that does not belong to any of the legislative, judiciary, or executive branch of the government and ensures independence and pluralism in carrying out its duties and activities

Investigates individual human rights violations and remedies therefor and recommends on matters that require reform or improvement including statutes, institutions, policies and practices of potential violation of human rights

A quasi-international organization that assesses the compliance of national laws and systems to international human rights standards in collaboration with the United Nations and other international organizations.

The NHRCK investigates and researches human rights-related laws, policies, and practices, provides recommendations for improvement, offers opinions on human rights cases upon request by a court (including the Constitutional Court) or as needed, and gives views on treaty ratification and implementation.

The NHRCK investigates and provides redress for violations of constitutional rights (Articles 10-22) by public institutions, addresses discriminatory acts by both public institutions and private entities without reasonable grounds, and handles cases of sexual harassment in workplaces and the military, as well as human rights violations or discrimination in the military.

The NHRCK conducts educational and promotional activities to enhance human rights awareness, provides human rights education to various sectors including public officials, educators, and military personnel, integrates human rights into school curricula, develops and distributes educational materials and media content, promotes a culture of human rights, and operates a human rights library.

The NHRCK collaborates with domestic and international civil society organizations, human rights defenders, the UN, and other national human rights institutions to identify and address human rights issues, support local human rights networks, and implement cooperative projects to promote human rights globally.
